#### Roundtable RT3-Roundtable OECD

The substantial and territorially differentiated impact of the COVID-19 pandemic on our lives and economies reinforces the importance of place-based, co-ordinated policy responses. As we move beyond the crisis, OECD countries need to ensure that policies move from reaction to the crisis to addressing the profound structural changes we need to address both the COVID-19 crisis and climate change. According to new OECD data, OECD countries and key partner economies have so far allocated USD 336 billion to environmentally positive measures within their COVID-19 recovery packages. Well-being benefits beyond the protection of the environment, for example from lower air pollution, as well as growth in new green technologies, could more than offset the costs of green transitions in many places. However, in some places, the transition costs will be higher. Support will be needed to address the needs of vulnerable communities and to avoid new geographies of discontent.
